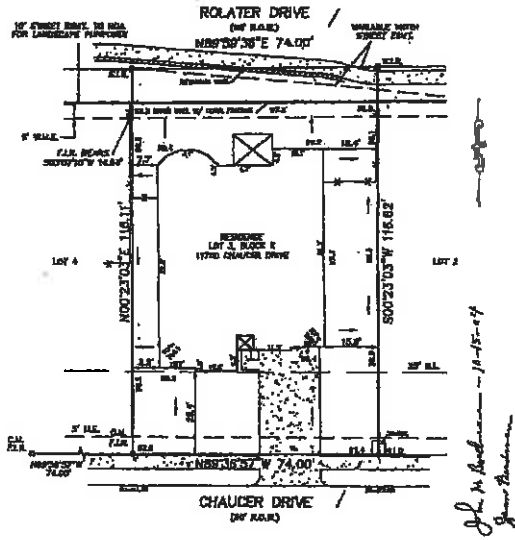


SURVEY PLAT
