
4. To the best of our actual knowledge and belief, since June 7th, 2012 there have been no:

- d. conveyances, replattings, easement grants and/or easement dedications (such as a utility line) by any party affecting the Property;

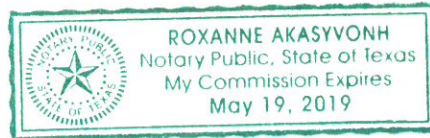
