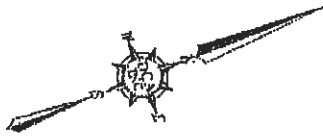
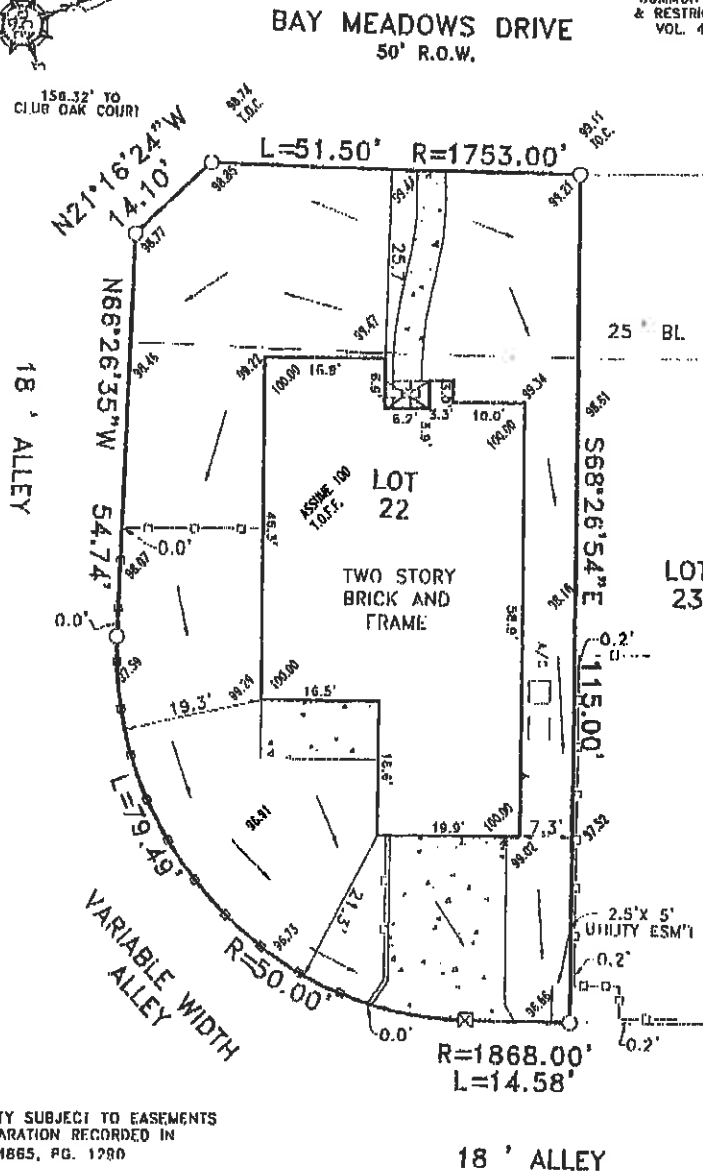


SURVEY PLAT
